09/15/17 through 09/22/17

15-Sept-17 Deputies contacted a vehicle in the Town of Otis. Upon further investigation, Michael Rogers was arrested on charges of driving under restraint while being a habitual traffic offender and possession of a schedule II controlled substance. Mr. Rogers was transported to the Washington County Justice Center and held on a \$7500.00 bond. Deputies also impounded the vehicle Mr. Rogers was driving. After obtaining a search warrant for the vehicle deputies discovered drug paraphernalia, methamphetamine and marijuana.
