09/22/17 through 09/29/17

- 22-Sept-17 Deputies issued several ordinance violations in the Town of Akron.
- 22-Sept-17 Deputies were dispatched to a traffic accident in the Town of Akron. Deputies cited Earl Harwood for limitations on backing.
- 23-Sept-17 While in custody, deputies arrested Randy Vanwinkle on a warrant out of Washington County Courts. Mr. Vanwinkle is being held on a \$1000.00 bond.
- 24-Sept-17 Deputies found a license plate on the side of Hwy 34 and CO RD BB. The plate was later returned to its owner.
