10/13/17 through 10/20/17

13-Oct-17 Deputies were dispatched to a medical assist at a residence on Hwy 6. Upon arrival the party was deceased. The coroner took over the scene.

13-Oct-17 Deputies were called to Woodlin School on a student who was agitated for unknown reasons. The student had damaged doors in the school. Case is under investigation.

14-Oct-17 Deputies were dispatched to a vehicle accident on CO RD QQ. Upon arrival it was determined that there were no injuries and moderated damage to the vehicle. Jerry Collin Patterson had backed his vehicle into a parked car in his driveway. Patterson was cited for unsafe backing.

14-Oct-17 Deputies responded to possible burglary in the Town of Otis. Upon further investigation, it was determined that the suspect(s) never gained entry to the building. Case is under investigation.

18-Oct-17 Deputies were dispatched to a possible disturbance in the Town of Otis. After completing the investigation, Brad Goble was arrested for harassment. He was transported to the Washington County Jail and was later released on a \$750.00 PR/Surety Bond.

18-Oct-17 While in custody, deputies arrested Tiffany Morgan on a warrant from the Department of Corrections for parole violation. Morgan is being held without bond.

19-Oct-17 While in custody, deputies arrested David Kirby on a warrant out of Logan County for criminal mischief. He is being held without bond.
