- 14-Jul-17 Deputies issued a citation in the Town of Akron for overgrown weeds.
- 14-Jul-17 Deputies arrested Dillon Armstrong on a warrant out of Yuma County. There was no bond. He was later transported to Yuma County.
- 15-Jul-17 David Fierro-Rason was transported to Washington County Justice Center from Ft. Morgan on a warrant out of Washington County warrant. He is being held on a \$10,000.00 bond.

- 16-Jul-17 Deputies received a report of a dog at large at 6th & Date in Akron. Deputies transported the small tan and brown Chihuahua to the Akron Pound. The owner, James Burkett was issued a warning for dog at large.
- 16-Jul-17 Deputies responded to a family dispute in the Town of Otis. Upon arrival it was found to be a verbal altercation between two parties and it had not become physical. Due to lack of criminal intent no charges were filed.
