12/01/17 through 12/08/17

01-Dec-17 Deputies were dispatched to a possible burglary in Washington County. Upon arrival Justin Horinek was seen removing items for a shop on the property. Horinek was arrested and transported to Washington County Justice Center and charged with 2nd degree burglary, theft, 3rd degree criminal trespass and a probation violation out of Morgan County for failure to appear. Horinek is being held on a \$5100.00 bond.

02-Dec-17 Deputies were dispatched to a possible family disturbance in the Town of Otis. Upon arrival deputies contacted several parties at the residence. The juveniles involved were spoken to and released to their parents. Department of Human Services was contacted about the incident.

02-Dec-17 Deputies received a report of possible vandalism to a vehicle in the Town of Otis. Upon arrival it was determined the vehicle had been vandalized. The vehicle's antenna was bent and there was a hole in the back window. Case is under investigation.

03-Dec-17 Deputies were called to a residence in the Town of Akron on a possible hit and run. The hit and run occurred between Dec. 2nd and Dec. 3rd. Deputies observed damage to the vehicles rear door. Case is under investigation.

04-Dec-17 Deputies received a call about a dog at large. Deputies contacted the owner, Daton Harris and issued him a citation for dog at large 1st offense. Harris was also given a warning to have his dog licensed with the town or he would be issued a ticket for no license.

05-Dec-17 Deputies were dispatched to a cold domestic in the Town of Akron. After further investigation, Shane Griffin was arrested for harassment and domestic violence. Griffin was later released on a \$1000.00 PR/Co-singed Bond.

06-Dec-17 Deputies arrested David Fierro-Rason on a warrant out of Washington County. Fierro-Rason was later released on a \$2500.00 PR/Co-signed bond.

06-Dec-17 Deputies issued an ordinance violation in the Town of Otis.
