12/08/17 through 12/15/17

08-Dec-17 Deputies received a call about an abandoned BMX bike at the Akron City Park. Deputies took possession of the bike. The bike is being held at the Washington County Sheriff's Office until the owner is located.

08-Dec-17 Deputies were called to the 500 block of Ash Ave for a possible trespass. After further investigation it was determined that the party Cassandra Kershaw was not trespassing but was found in possession of Methamphetamine and related drug paraphernalia. She was arrested and transported to Washington County Justice Center. She is being held on a \$1000.00 bond. A search warrant was also obtained to search the residence. During the search deputies found additional methamphetamine, marijuana and related paraphernalia. Case is under investigation.

09-Dec-17 While in custody, Ashley Galloway was arrested on a felony warrant. Galloway was released on a \$2500.00 bond.
