30-Mar-18 Deputies observed an individual in the Town of Akron with more dogs than the town allows. Deputies explained that this was a violation of town ordinances and they were told how to resolve the issued.

30-Mar-18 Deputies were approached by two parties at the Washington County Sheriff's Office. The parties advised that they were victims of fraud by check. The suspect(s) have not been found and the case is under investigation.

30-Mar-18 Deputies received a call of a dog at large in the 100 block of N. 7<sup>th</sup> in the Town of Akron. The dog was taken to the Akron Pound where the owner later picked up the dog. The owner was cited for dog at large and not having the animal licensed with the Town of Akron.

31-Mar-18 Deputies were notified of a possible harassment in the Town of Akron. Index cards were left on the vehicle. Case is under investigation.

31-Mar-18 Deputies were notified by a resident that he was being followed by an ex-employee. Didn't wish to press charges just wanted to make a report.
