10-Aug-18 While in custody, Matthew Thomas was arrested on a warrant out of Jefferson County District Court. Thomas is being held on a \$3000.00 bond. Thomas also has a warrant out of Tarrant County Court in Texas with no bond.

10-Aug-18 Deputies were dispatched to a civil dispute in the Town of Akron. The individuals were given instructions on how to resolve the issue through civil court.
