- 19-Oct-18 While in custody, Larry Sanchez was arrested on a warrant out of Larimer County District Court. Sanchez is being held on a \$2,000.00 bond.
- 20-Oct-18 Deputies received a report of a protection order violation. The case is under investigation.
- 20-Oct-18 Deputies were dispatched to a suicidal party in the Town of Akron. Deputies contacted the Department of Human Services and they were able to resolve the issue.
- 21-Oct-18 Deputies were dispatched to the Platner area for ATV's that were driving reckless. Deputies located numerous ATV's at a residence in the area and a male party was contacted. He was warned to not be on the roadway.
- 21-Oct-18 Deputies were notified of a missing elderly male northeast of Akron. The male party was later located the following morning and was in good health.
- 21-Oct-18 Deputies contacted Chris Bowman on a traffic violation and he was found to be driving under the influence. Bowman was arrested and transported to the Washington County Justice Center. Bowman was later released on a \$ 2000.00 bond.
- 22-Oct-18 Deputies received a report of a hit and run accident at the Akron School. When deputies arrived they were able to determine that the accident did not happen there and discovered that it happened north east of Akron. Colorado State Patrol took over the accident.
- 23-Oct-18 Deputies arrested Raymond Jones on a warrant out of Washington County Courts. The warrant was later quashed and Jones was released.
- 25-Oct-18 Deputies were dispatched to a possible suicidal party in the Town of Akron. Deputies transported the individual to the Sheriff's Office and placed the individual in contact with an Emergency Response Therapist.
