08/23/19 through 08/30/19

August 24, 2019

Deputies were dispatched to a suicidal party in the Town of Akron. Party was later taken to the hospital for evaluation.

August 25, 2019

Deputies were dispatched to a family disturbance in the Town of Akron. Upon further investigation it was determined that it was an argument between mother and son and that it was just disciplinary action within the parents' rights. DHS was notified.

Deputies received a report of a suicidal party in the Town of Akron. Deputies transported the party to the hospital to be evaluated by mental health.

Deputies were dispatched to a possible structure fire in the 37000 block of CO RD DD. Upon arrival, the Akron Volunteer Fire Department said that the fire had been burning for quite a while before they arrived.

August 26, 2019

Deputies arrested Colin Clapper on a warrant out of Wisconsin. Clapper is awaiting extradition to Wisconsin.

Deputies were dispatched to a possible dog bite in the Town of Akron. Deputies contacted the victim and after photographing the area and looking at it deputies determined that it was just scratches and there were no bites.

Deputies were called to a stray cat in the yard in the 600 block of Adams. The cat was taken to the pound and the owner, Halie Atwood was cited for animal at large 2<sup>nd</sup> offense.

Deputies were notified of legal paperwork lying on Hwy 34. The paperwork was collected and the owner was called but did not wish to talk to deputies. The paperwork was later shredded.

August 28, 2019

Deputies received a call about a possible assault that had occurred in the Town of Akron. Deputies arrested David Hardy and charged him with 3<sup>rd</sup> degree assault and domestic violence. Hardy was later released on a \$1000.00 PR bond.

Deputies received a report of a possible child abuse. Upon further investigation, deputies issued a summons for child abuse resulting in injury to Sara Cozad.

Deputies issued an abatement to a resident in the Town of Akron for overgrown weeds. The resident was given 7 days to take care of the weeds.

August 29, 2019
