09/06/19 through 09/13/19

September 06, 2019

Deputies received a report of a kitten that was found in a shed in the 200 block of W 7<sup>th</sup> St. Once deputies arrived on scene the reporting party found another kitten. Both kittens were taken to the pound and one of the kittens was later euthanized due to poor health. Flyers were placed around town for the other kitten.

Deputies received a call from party wondering what his limitations and rights were in regard to self-defense. The party said he had been assaulted in downtown Akron but did not wish to press charges.

September 7, 2019

Deputies received a report of a disoriented person at Davis Brothers. Joshua Henry was later arrested on charges of protection order violation. Henry was later released on a \$5000.00 PR bond.

September 8, 2019

Deputies received a report of a foster parent threatening a child in his care. Case is under investigation.

Deputies received a report of a custodial grandmother receiving harassing messages from the child's mother. Case is under investigation.

Deputies did a civil standby in Akron. The party decided to leave the house as her husband was angry and she was unsure what his mood would be. The party decided to stay at a different residence for the night.

September 9, 2019

Deputies took a report of a possible animal abuse in the 300 block of Birch Ave. When deputies arrived on scene they spoke with a party who said that he had shot a bb gun at the cat to get it out of his yard. The cat was later euthanized due to extensive injuries. No charges were filed.

Deputies were called to the 700 block of Eagle for a dog at large. The dog was located and the owner was notified and given a warning for dog at large.

Deputies arrested Gregory Grooms who turned himself in on a Washington County warrant for failure to appear. Grooms was later released on a \$500.00 bond.

September 11, 2019

Deputies set a cat trap in the 500 block of Adams to trap feral cats. A cat was in the trap when deputies checked it. The cat was taken to the pound and flyers were placed around town.

Deputies received a call about a kitten in the 300 block of Custer. The kitten was taken to the pound and flyers were placed around town.

September 12, 2019

Deputies were dispatched to a party claiming they were being chased in the Town of Otis by a person with a gun. When deputies arrived on scene they observed the person who appeared to be on some sort of drugs. Deputies had EMS transport the party to the hospital to be checked out. Deputies determined that there was no one chasing the party with a gun.

Deputies were dispatched to a disturbance in the Town of Akron, in which a student was refusing to go to

school. The student was subsequently transported to school by a guardian.

Deputies received a report from a Greeley resident that an Akron business had stolen property from them. Further inquiries are necessary to determine whether the case is criminal or civil.

September 13, 2019

Deputies were called to a dog at large in the 600 block of Fremont. The dog was taken to the pound and flyers were placed around town.

Deputies were called to the 300 block of W 4<sup>th</sup> St. for a dog at large. The dog was taken to the pound and the owner, Darrin Lambert was issued a citation for dog at large, 1<sup>st</sup> offense.

Deputies spoke to a party that wanted to report the possible theft of firearms. The matter was determined to be civil.

Deputies were dispatched to Z & Z Towing's impound lot as the lock and chain on the gate had been stolen. One of the vehicles inside had the windows broken and some of the interior may have been stolen. Case is under investigation.
