March 13, 2020

Deputies were dispatched to a vehicle that had slid off of Hwy 34 on 2 separate occasions. Deputies arrived on scene and contacted the driver. The driver, Kashlie Burton was issued a summons for careless driving and driving under revocation.

March 14, 2020
